| Overall | Green | Green | The programme is progressing well, with significant progress being made by all projects. An effective handover was given to the new Programme Manager. Recruitment of all Academic Partners to start in early Sept was successful. 1 of the 3 Student Placements has been appointed. Early Adopter Schools and Special Projects for eSFG (electronic submission, feedback and grading) have now been agreed and workshops are planned or underway. Ongoing Core Systems work with the support centres and RISIS development is also progressing well and will mean that Sub Modular Marks recording and calculation will be available for the 2017/18 Academic Year for undergraduate assessments. Effective, ongoing engagement and communication continues and a review of the Stakeholder Engagement and Communications Strategy is underway to produce a full communications calendar as we enter the next busy stage of the programme. |

PROGRAMME SUMMARY

Achievements this period:

- Completion of a full handover to new Programme Manager.
- Successful recruitment of 6 (part-time) Academic Partners to join the team for a year.
- Successful recruitment of 1 of 3 Student Placements to join the team for a year.
- New Junior BA (permanent member of staff) has started within the team.
- Early adopter schools agreed and finalised as SAGES and APD communication circulated to Leaders for cascading. Initial workshops with both schools successfully held and excellent progress being made.
- Agreement from IoE and HBS of their involvement in special projects for the eSFG work stream.
- Consultation commenced on potential Occupational Health, disability and accessibility impacts.
- Continued RISIS development to build the enhancements required to support the load and display of Sub Modular Marks, as well as agreeing all specifications at a field level of detail
- First draft of assessment data successfully loaded into RISIS.
- RISIS User Acceptance Testing (UAT) and associated training planned.
- End of term communications activities to all around progress and next steps, in particular to formally announce the Early Adopters.
- Presentations/workshop given at Telfest, which were well received.
- Change Impact Assessment commenced to more thoroughly identify change management activities.
- Review of Stakeholder Analysis, Engagement and Comms Strategy and Comms Calenda commenced.
- Programme Board briefed on Learning Analytics exploratory project and agreed that outcomes and options will be presented in October for the Board to decide next steps/approach.
- Programme Board Risk Management Workshop scheduled (Sept).
- Reporting Workshop held with CQSD to identify an initial set of reporting requirements.

| W/S 1: Supporting Change for EMA | Amber | Green | Moved to amber due to a gap in Workstream Management support meaning that change management planning is running slightly behind delivery. However this is being mitigated with minimal impact overall. A Training Manager starts on 7 th Aug who will assist with planning and consultation around the production on-line EMA supporting resources as well as support imminent Core System Training and planning/consultation for eSFG training. The refined draft of the Stakeholder Engagement and Communication Strategy and the Comms Calendar will be prepared during August for the Supporting Change Workstream Board to review and agree further consultation. Progress has been made on defining baseline metrics and benefits for the programme, which will be finalised during August and September. |
| W/S 2: eSFG and Data | Green | Green | This workstream is progressing well. Early Adopters and Special Projects workshops are either underway or planned, enabling enhancements/necessary tailoring of process as well as testing the support approach and needs for a wider roll-out. Discussions have commenced with Occupational health to ensure occupational health, disability and accessibility impacts are fully considered – this will be followed up during August and Sept by the Disability and Accessibility Advisor and recommendations given. |
| W/S 3: Core Systems | Green | Green | This Workstream is progressing well. Initial load of assessment data into RISIS is in progress and User Acceptance Testing commences in early August which will also enable further data cleansing. New RISIS screens for Programme Administrators and Module Conveners are in development. In light of the recently revised Extenuating Circumstances Policy, this Workstream is reviewing the impact of sub modular marks development in RISIS to date and considering whether it should be included in planned systemisation - to be discussed at the Programme Board in August. Supplier consultancy has been secured for the rest of the year, timed well to ensure we have the most appropriate resources. |
